PROJECTS WHICH HAD STOPPED DUE TO FINANCIAL CONSTRAIN**

Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Nquthu Municipality to amend the existing contract by re-instatement the contractors to complete LED projects.

The above-mentioned projects have a life span of more than five years which has raised numerous audit findings for the Municipality. Some projects were 75% towards completion but have suffered a great deal of vandalism as a result of being no funds to complete and handover to the identified beneficiaries. The Municipality could not afford security services for this long period. The above-mentioned projects were projected to create sustainable job opportunities and enhance the economy of Nquthu town.

As a remedial measure, the municipality is advised to complete these projects to a level that they can be handed over so that they do not become fruitless and wasteful expenditure.
