



# NQUTHU MUNICIPALITY TARIFF OF CHARGE 2024/2025

## FACTORS AFFECTING THE TARIFFS FOR THE BUDGET YEAR.

- 1) The municipality in preparation of its tariffs has taken CPI, inflation forecast **(5.3%)** into consideration.
- 2) Other charges are regulated i.e. electricity. NERSA has determined annual guideline increase of **11.66%** by municipalities.
- 3) National Treasury encourages municipalities to maintain tariff increases at levels that reflect an appropriate balance between the affordability to poorer households and other customers while ensuring the financial sustainability of the municipality. The Consumer Price Index (CPI) inflation is forecasted to be within the upper limit of the 3 to 6 per cent target band; therefore, municipalities are required to justify all increases in excess of the projected inflation target for 2024/25 in their budget narratives, and pay careful attention to the differential incidence of tariff increases across all consumer groups. In addition, municipalities should include a detail of their revenue growth assumptions for the different service charges in the budget narrative.
- 4) Safeguard the financial sustainability of the municipality and ensuring that tariff increases are locked in before the start of the financial year
