Terms of Reference: Multi-Floor Office Fire Marshal In a multi-floor office, fire marshals operate on a zonal system. Each marshal is responsible for a specific floor or wing to prevent bottlenecks in stairwells and ensure total building clearance. 1. Key Objectives

- **Floor Clearance:** Guarantee the total evacuation of the assigned floor during an alert.
- **Stairwell Safety:** Manage traffic flow into emergency stairwells to prevent crushing or delays.
- **Hazard Mitigation:** Identify vertical risks, such as wedged-open fire doors that could allow smoke to travel between floors.

2. Routine Duties (Proactive)

- **Inspect Fire Doors:** Ensure all heavy fire doors leading to stairwells close fully and are never wedged open.
- **Check Emergency Signage:** Verify that illuminated exit signs and directional arrows are functional and visible.
- **Monitor Lift Lobbies:** Ensure signage clearly states, **"Do Not Use Lifts in a Fire"** and that lobbies are free of storage.
- **Track Occupancy:** Maintain an awareness of approximate daily staff numbers, hot-deskers, and visitors on your floor.
- **Review PEEPs:** Know which individuals on your floor require Personal Emergency Evacuation Plans and locate their designated buddies or evacuation chairs.

3. Emergency Duties (Reactive)

- **Initiate Evacuation:** Command the floor to evacuate immediately when the alarm sounds, regardless of whether it is a drill.
- **Direct Stairwell Traffic:** Guide occupants to the nearest designated emergency staircase. Do not allow the use of lifts.
- **Conduct Floor Sweep:** Methodically check all areas on your floor, including:
 - Meeting rooms and boardrooms
 - Restrooms and shower facilities
 - Kitchenettes and print hubs
 - Server rooms and storage closets
- **Isolate Hazards:** Close all office doors after sweeping rooms to contain fire and smoke to that floor.
- **Deploy Evacuation Chairs:** Assist trained personnel in moving mobility-impaired individuals down the stairwells using specialized equipment.
- **Report to Chief Marshal:** Evacuate via the stairwell once the floor is clear. Immediately report your floor status (e.g., *"Floor 2 clear"* or *"Floor 2 clear, but one person remaining in refuge area"*) to the Chief Fire Warden at the central assembly

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
